Tune-Up Rebates

Systems five years and older are eligible for a rebate. Only one rebate per system is available during a five-year period.

Terms and Conditions

1. There must be a PSEG Long Island residential electric account at the installation site in the applicant's name.
2. Unit(s) must be purchased and installed between 11/6/2023 to 12/31/2024.
3. Rebate application must be submitted by a Home Comfort or Home Comfort Plus Partner.
4. Please allow up to 60 days for delivery of the rebate check.
5. Qualifying units must be listed in the AHRI directory at the time of installation. Visit www.ahridirectory.org to verify equipment eligibility. Qualifying cold climate air source heat pumps must be listed on Northeast Energy Efficiency Partnerships (NEEP) Cold Climate Air Source Heat Pump Specification Product Listing. Visit ashp.neep.org to verify equipment eligibility.
6. All units must be installed with the matching pieces specified in the AHRI directory.
7. It is the customer's responsibility to ensure contractor has proper licenses, certifications and insurance.
8. Replacement of systems less than five years old, that were rebated, are not eligible for a rebate unless the SEER level of the replacement unit is higher than the existing unit by at least one full SEER level. These rebates apply to new and replacement total system installations performed during the term of this rebate program. The Condenser (outdoor), and Coil/Air Handler (indoor) must be installed new and constitute one unit. Partial system replacements do not qualify.
9. PSEG Long Island reserves the right to inspect the equipment installation to ensure compliance with program requirements. Failure to allow PSEG Long Island access to the equipment will result in a denial of the rebate application.
10. PSEG Long Island is not responsible for any tax liability imposed as a result of rebate payments.
11. PSEG Long Island reserves the right to use the customer rebate to credit accounts in arrears.
12. Please refer to the application for any specific program eligibility requirements.
