**Cooperative Advertising and Training Incentives** 



#### NYSERDA offers a cost-share incentive program for Clean Heat Connect Partners and their installation contractors.

If you plan to build a new training center, to buy new equipment, or to advertise and promote your clean energy business, NYSERDAs **Cooperative Advertising and Training for Clean Energy Partners Program (PON 4482)** can help.

This program is open to both new and returning applicants. However, your application must be submitted prior to the start of an initiative. Initiatives already underway will not be accepted.

Incentives cover up to 25 percent of training equipment and up to 50 percent of expenses associated with training activities. Each training sessions must have a minimum of 10 participants. All participants must be both NYS residents and currently employed in the HVAC industry.	Incentives cover up to 50 percent of advertising activities. Annual incentive caps are based on type of activity and type of business, and are addressed in the application process. Caps renew each calendar year (January 1), and any unused incentives cannot carry over from the previous year.
